This Memorandum of Understanding ("MOU") is made between:

SAM RATULANGI UNIVERSITY of Kampus Unsrat, Kelurahan Kleak, Manado, Indonesia 95115 – and –

SEAMEO BIOTROP of JI Raya Tajur Km.6 Bogor 16134, West Java, Indonesia ("Collaboration Partner")

1. INTRODUCTION

Sam Ratulangi University and SEAMEO BIOTROP ("Parties") want to collaborate with each other so as to promote the advancement of international understanding, dissemination of learning and strengthening of cultural ties. They have entered into this MOU to create a foundation from which such collaboration may be developed.

2. MUTUAL INTEREST

The Parties share a mutual intent to support and promote the spirit of this MOU by encouraging academic collaboration, including:

- 2.1. development and promotion of:
 - 2.1.1. research;
 - 2.1.2. training; and
- 2.2. Sponsoring cooperative seminars, workshops and other scientific meetings of matters of mutual interest.

3. NATURE OF COLLABORATION

- 3.1. Sam Ratulangi University and SEAMEO BIOTROP propose to develop links between the two institutions and support the aims of this MOU by way of:
 - 3.1.1. staff exchanges;
 - 3.1.2. research and internship programmes; and
 - 3.1.3. collaborative projects in areas of mutual interest.
- 3.2. The Parties recognise that the collaborative activities referred to in paragraph 3.1 will need to be conducted by way of separate, written agreements.



Those agreements will set out the Parties' various rights and obligations in respect of those activities.

4. DURATION

- 4.1. Subject to paragraph 4.2, this MOU will commence on the date it is fully executed and will last for 3 (three) years.
- 4.2. Either Party may terminate this MOU by giving the other Party 3 months' written notice of termination.

5. NOMINATED REPRESENTATIVES

Each Party's nominated representative is responsible for the development and implementation of this MOU, including receiving and acting on proposals for collaborative activities referred to in paragraph 3.1.

6. LEGAL ASPECT

This MoU is to ensure the parties' willingness to cooperate in an effort to advance the things that have been mentioned on this MoU!
