# MEMORANDUM OF UNDERSTANDING BETWEEN THE SIX INDONESIAN UNIVERSITIES AND THE UNIVERSITY OF GLASGOW

THIS AGREEMENT is made on Thursday, 30 January, 2014.

BETWEEN THE SIX INDONESIAN UNIVERSITY CONSORTIUM, CONSISTS OF UNIVERSITAS CENDRAWASIH, located in Jayapura; UNIVERSITAS SAM RATULANGI, located in Manado; UNIVERSITAS UDAYANA, located in Jimbaran; UNIVERSITAS JEMBER, located in Jember; UNIVERSITAS ANDALAS, located in Padang; UNIVERSITAS SUMATRA UTARA, located in Medan, hereinafter referred to as the "First Party"

AND

THE UNIVERSITY OF GLASGOW, located in Scotland, United Kingdom, hereinafter referred to as the "Second Party".

Both parties hereinafter referred to as "The Parties"

#### RECITALS

WHEREAS The Parties wish to co-operate over establishing academic activities.

**AND WHEREAS** this Consortium Agreement sets out the relationship between the Parties and the University of Glasgow.

#### IT IS HEREBY AGREED AS FOLLOWS:

#### 1. **DEFINITIONS**

In this Agreement, the following terms shall have the following meanings:

'Cooperation' means all efforts to improve academic capacity and capability among the Parties.

'Academic Activities' mean all academic activities such as teaching, research, and publication.

'Effective Date' means the date when the Parties have signed this Agreement.

'Steering Committee' means the committee responsible for driving the policies of the cooperation, consists of Rector/President of the Parties.

'Organizing Committee' means the committee appointed to be responsible for driving the Consortium whose individual members are set out later.

#### 1. PURPOSE OF THE MOU

The purpose of the MoU is to develop cooperations to enhance the academic capacity and capability among the Parties.

#### 2. COMMENCEMENT AND DURATION

This Agreement shall commence on the Effective Date 30 January 2014 and the cooperation has a duration of 4 (four) years, unless otherwise agreed in writing by the Parties.

## 3. SUPPORTING FUNDING

Activities will be supported by Directorate General for Higher Education of Indonesia, British Council, the Parties or any other institution.

#### 5. RESPONSIBILITIES OF THE PARTIES

The Parties have responsibility to:

- 5.1 Use all best efforts to ensure the accuracy of any information or materials it supplies hereunder and promptly to correct any error therein of which it is notified.
- 5.2 Agree and undertake at its own expense to make the Personnel available to implement all activities.
- 5.3 Not to issue any press releases or other such publicity materials relating to the work of the Consortium without obtaining prior approval from the other Parties.
- 5.4 Carry Out Establish Steering Committee and Organizing Committee

#### 6. COMMITEES RESPONSIBILITIES

- 6.1 Organising committee undertakes the tasks assigned by the Steering Committee and all other of its obligations under this Agreement.
- 6.2 In implementing the tasks, the secretariat office is moved round started firstly at Universitas Udayana and then at the Universitas Cendrawasih, Universitas Sam Ratulangi, Universitas Jember, Universitas Andalas, Universitas Sumatera Utara, and finally at the University of Glasgow
- 6.3 Towards the Steering Committee, each Party hereby undertakes to supply promptly the required information or documents to fulfil obligations pursuant to this Agreement.

## 7. REMOVAL OR WITHDRAWAL OF PARTIES FROM THE CONSORTIUM

### 7.1 REMOVAL OF PARTIES

Without prejudice to+ any other rights or remedies open to the Consortium, the Steering Committee may, after a two-thirds majority vote of the full Steering Committee in favour of termination, and via a written notice served on the Party, terminate a Party's membership of the Consortium, if the Party did not obey the commitment to the agreement.

## 7.2 WITHDRAWAL OF PARTYS

A Party may withdraw from the Consortium only with the unanimous agreement of the remaining Parties.

# 7.3 CONDITIONS CONSEQUENT ON REMOVAL OR WITHDRAWAL

In the event of withdrawal or expulsion of a Party, the Consortium will be liable to meet only the cost of any work undertaken up to the point at which a Party ceases to be a member of the Consortium. In all cases, the Consortium reserves the right of access to any work produced in the course of the Party's work as part of the Consortium.

#### 8. FORCE MAJEURE

No Party will be deemed to be in breach of this Agreement, nor otherwise liable to the other for any failure or delay in performance of this Agreement if it is due to any event beyond its reasonable control other than strike, lock-out or industrial disputes but including, without limitation, acts of God, war, fire, flood, tempest and national emergencies and a Party so delayed shall be entitled to a reasonable extension of time for performing such obligations.
