**OBIHIRO UNIVERSITY of AGRICULTURE and VETERINARY MEDICINE**, 2-13 Inada-cho, Obihiro, Hokkaido 080-8555, Japan

**1. INTRODUCTION**

Sam Ratulangi University and Obihiro University of Agriculture and Veterinary Medicine ("Parties") want to collaborate with each other in Tropical Diseases. They have entered into this MOU to create a foundation from which such collaboration may be developed.

**2. MUTUAL INTEREST**

The Parties share a mutual intent to support and promote the spirit of this MOU by encouraging academic collaboration, including:

- 2.1. development and promotion of:
  - 2.1.1. research;
  - 2.1.2. research training;
  - 2.1.3. teaching, including training programmes;
- 2.2. sharing and dissemination of academic materials;
- 2.3. exchange of, and cooperation between, respective staff, scholars and students, including supervision and examination of students and the training and upgrading of staff; and
- 2.4. sponsoring cooperative seminars, workshops and other academic meetings of matters of mutual interest.

**3. NATURE OF COLLABORATION**

- 3.1. Sam Ratulangi University and Obihiro University of Agriculture and Veterinary Medicine will conduct some scientific works in Tropical Disease circumstances.
- 3.2. The Parties recognise that the collaborative activities referred to in paragraph 3.1 will need to be conducted by way of separate, written agreements (Further technical issues will be elaborated in more detail in any other subordinating document(s) below this MOU). Those documents will set out the Parties' various rights and obligations in respect of those activities.

**4. DURATION**

- 4.1. Subject to paragraph 4.2, this MOU will commence on the date it is fully executed and will last for 3 years.
- 4.2. Either Party may terminate this MOU by giving the other Party 3 months' written notice of termination.

**5. NOMINATED REPRESENTATIVES**

- 5.1. The Parties' nominated representatives are:  
     for Sam Ratulangi University– to be appointed  
     for Obihiro University of Agriculture and Veterinary Medicine – to be appointed
- 5.2. Each Party's nominated representative is responsible for the development and implementation of this MOU, including receiving and acting on proposals for collaborative activities referred to in paragraph 3.1.

**6. LEGAL ISSUES**


