Memorandum of Understanding
between
Griffith University
and
Universitas Sam Ratulangi (UNSRAT)

Griffith University, Queensland, Australia and **Universitas Sam Ratulangi (UNSRAT)**, Manado, North Sulawesi, Indonesia (individually a party and collectively parties to this Memorandum) believe that:

1. Mutual benefit can be derived from scholarly interaction, cultural interchange, co-operative research and other forms of academic collaboration.
2. The parties regard the following areas of co-operation as desirable and feasible:
 - (i) Exchange of students and academic staff members;
 - (ii) Collaborative research and possible exchange of academic papers;
 - (iii) Mutual assistance in the preparation of seminars, conferences and workshops;
 - (iv) Exchange of academic publication materials or other information;
 - (v) Co-operation in training projects for specified areas of development;
 - (vi) Professional Development Programs for Government and Industry;
 - (vii) Jointly supervised Programs;
 - (viii) Collaboration on International Research grants and in particular, AusAid and Asian Development Bank Grants;
 - (ix) Opportunities for other forms of co-operation, such as the delivery of award and non-award courses.
3. In particular, the parties wish to collaborate in the following areas but this is not exclusive of other areas of interest:
 - Urban Development and Environmental Management, with regards to
 - Urban Studies
 - Planning
 - Transportation
 - Public Health
 - Environmental Development
 - Environmental Protection and Quarantine
 - Impact of Climate Change.
4. The terms of specific areas of co-operation shall be further considered and agreed upon in writing by the parties prior to the initiation of any particular activity.
5. Any specific program will be subject to mutual consent, availability of funds and approval of both parties.
6. The parties agree that this Memorandum of Understanding is not a formal legal agreement giving rise to any legal relationship, rights, duties or consequences, but it is only a definite expression and record of the purpose of the parties to which the parties are bound in honour only.

7. This Memorandum of Understanding shall remain in effect for a period of five (5) years from the date of signing and it may be renewed for a further five (5) years by the mutual agreement of both parties. This Memorandum may be amended or modified at any time by the mutual consent of the co-operating institutions. The Memorandum can be terminated at any time by either party upon provision of six (6) months written notice to the other party.


