



# MEMORANDUM OF UNDERSTANDING

# This Memorandum of Understanding (MoU) is made between:

**SAM RATULANGI UNIVERSITY** (hereinafter referred to as "UNSRAT") a state university of The Republic of Indonesia whose address is at Kampus Unsrat, Kelurahan Kleak Manado (95115), Indonesia;

- and -

**DALIAN MARITIME UNIVERSITY** (hereinafter referred to as "DMU") a state university of The People's Republic of China, whose address is in Dalian, Liaoning, China;

(UNHAS and DMU hereinafter referred to a singularity as "party" and collectively as "parties")

#### Article 1.

#### INTRODUCTION

Kemal and Nasser Institute and Dalian Maritime University recognizing the contribution which each party is making in the fields of maritime education, training and research, agree to this Memorandum of Understanding (MoU), which would permit scholarly pursuits beneficial to both parties and promote friendship between each party.

#### Article.2.

#### **MUTUAL INTEREST**

Subject to mutual consent, the areas of cooperation will include, but not limited to:

- a) Staff and lecturer exchanges and visits
- b) Joint educational and training projects
- c) Invitation to and co-hosting of lectures, seminars, and conferences
- d) Periodic exchange of information of mutual interest
- e) Joint Graduate/Post Graduate Program of Dual Degree
- f) Joint Research and Development
- g) Joint Scientific Journal Publication
- h) Patenting of Joint Intellectual Property Right

#### Article.3.

## **IMPLEMENTATION**

This MoU may be complemented with annexes or Detailed Letter of Cooperation concerning specific forms of cooperation between the parties. These annexes or the Letters may be proposed and signed on a later date. Once they are signed by both parties, these annexes and/or letters are considered as an integrated part of this MoU.

### Article.4.

### **DURATION**

This MoU will be effective upon the date of signature by the authorized representatives of the two parties, shall remain in force initially for a period of five years. It may be amended or extended by mutual written consent of the parties, and may be terminated by a written notice by a Party to the other Party upon 60-day calendar prior written notice.

#### Article.5.

### **LEGAL ISSUES**

- 5.1 Nothing in this MoU will create a legal relationship between the Parties or be legally binding on them. This MoU is to affirm the intent of the Parties to work together in good faith in an attempt to progress the matters described in this MoU.
- 5.2 This MoU is non-exclusive.
- 5.3 Unless otherwise agreed by the Parties, each Party shall bear its own costs in implementing this MoU.

### Article.6.

### LANGUAGE

This Agreement is executed in English, Chinese and Indonesian versions will be made upon the Parties' agreement.
